UKC® PREMIER NATIONALS SPECIALTY CONTRACT

Agreement between the United Kennel Club, hereafter referred to as "UKC"
and the host club hereafter referred to as the "Specialty Club."

A. Specialty Club Responsibilities:

1. The Specialty Club will be responsible for running the specialty or performance event to be held on the Wednesday prior to the Premier Nationals at the Kalamazoo County Expo Center and Fairgrounds. Specialty clubs are restricted to offering only the breeds or events outlined in their Constitution and Bylaws or as approved by UKC.
2. The Specialty Club must adhere to all scheduling and planning requirements.
 - a. The specialty may be held in an inside or outside ring. UKC will assign ring locations.
 - b. The Specialty Club will be responsible for the hiring, transportation, lodging, meals, and any other normal expenses incurred by the judge of their specialty, except as outlined in Section B. 6.
 - c. The Specialty Club will be responsible for their own ring supplies, including judges' books and scoresheets.
 - d. The Specialty Club will be responsible for providing stewards for their event.
 - e. The Specialty Club will be responsible for providing and awarding all trophies, prizes, and awards.
 - f. The Specialty Club will be responsible for cleanup of their ring and the immediate area, immediately after the conclusion of their event. Please throw away any trash and clean up after dogs.
 - g. The Specialty Club is to be considerate when hosting their event and use ring time wisely and to be aware that other specialty events may be scheduled to follow yours. Win photos should not be taken in the ring.
 - h. The Specialty Club will be responsible for handling all conflicts and will deal with complaints, misconducts, and disqualifications as they arise in relation to their events.

NOTE: Should any dog be disqualified for attacking, biting, or attempting to bite, please notify the UKC Event Superintendent immediately.

3. Following the event, the Specialty Club will be responsible for the following fees:
 - **If 12 or fewer dogs enter, a flat fee of \$30 is due.**
 - **If over 12 dogs enter, an event service fee of \$3/dog is due**
4. The Specialty Club hosting a conformation event, must offer Junior Showmanship, which will be limited to the specific breed(s) being offered at the event.
5. If the Specialty Club cancels this event at any time after the event has been published either on the UKC Event Calendar or in the Judging Program, the club will be charged a \$30 cancellation fee.
6. Any promotion of the specialty other than outlined in this contract will be the responsibility of the Specialty Club. Any club offering a raffle may do so but only on the day of their scheduled specialty. All clubs offering a raffle must abide by the Michigan Charitable gaming laws.
7. Raffle tables will be permitted at ringside only, and only during the specialty. All Specialty Clubs are required to return any additional tables and chairs, to their respective location, following the conclusion of their specialty.
8. The fairgrounds will close at 10:00 pm. All specialties must be completed and the ring and surrounding area cleaned up prior to the closing time.

B. United Kennel Club Responsibilities (UKC):

1. UKC will provide the event space and rings for the event.
2. UKC will provide ring mats and gates, examination tables, tables, and chairs.
3. If the Specialty Club hires a judge that is already on the panel for the Premier Nationals, the Specialty Club is responsible for paying the judge's honorarium for the specialty show and covering the judge's expenses on the day of their Specialty, including meals and a hotel room for the additional nights necessary for their specialty event.
4. UKC will have a limited supply of blank armbands available for specialty clubs. They can be picked up on the day of their specialty.
5. UKC will list the specialty event on the UKC Events Calendar and in the UKC Premier Nationals Judging Program if received in time for publication.

NEW ONLINE ENTRY SERVICE FOR OUR LICENSED CLUBS!



This premium service is offered at no cost to clubs, and is a perfect opportunity to create more efficiencies for your club officials surrounding the pre-entry process.

WHAT'S INCLUDED

- **UKC builds a custom entry page for your club's event (based on the information you've submitted in your event application).**
- **UKC publishes your event to the UKC website (like usual), and also links that calendar listing to your club's custom entry page.**
- **UKC provides your club with a link to the custom entry page for your board and members to share out.**
- **The club will appoint a Trial Secretary to receive an emailed copy of each event entry during the event's pre-entry open dates. This keeps your club up to date for planning, in real time.**
- **UKC collects entry information and entry fees from exhibitors plus a non-refundable service fee. After the conclusion of entries, UKC will retain the service fee and send the club the entry fees, minus recording fees of the pre-entered dogs.**
- **After the close of entries, UKC will send the club their entry fees 15 days prior to the event and the Event Secretary will receive a complete spreadsheet of the pre-entries collected for the event.**
