ENTRY INFORMATION

- Open event, with no event qualification requirements.
- All dogs must be UKC registered.
- Single registration is available on site to those who meet UKC single registration requirements. Note: Dogs with more than half coonhound are not accepted for registration as any breed of Cur. Bring a copy of the registration certificate and pedigree from an acknowledged registry, or contact UKC Hunting Ops to register your dog in advance.
- Enter on grounds on day of event. Hunt entry fee is \$40, show entry fee is \$15.
- Deadline to enter hunt: 7:00 am local time. No exceptions.
- See information below for the deadline to enter the show.
- Top 10 placements awarded in each one of the Cur and Feist hunts.

HUNT & SHOW DETAILS

- The hunt is conducted under a Full Elimination format. Current rules and procedures apply as noted in the rulebook for the year the hunt is being held in.
- All dogs, regardless of category, are drawn out together.
- Curs are separated from Feist and each compete in their own championship.
- 90-minute hunts in each round.
- All cast winners in each round will advance to the next round.
- A World Championship Bench Show will be held on Saturday during a time that is deemed suitable and determined as such for each unique championship. The deadline to enter the show will be announced on Saturday morning at the event. Nice awards to be displayed at the event.
